JOB SUMMARY:

In accordance with the Vision, Purpose, and Values, and strategic direction of the Vancouver Island Health Authority (Island Health) patient and staff safety is a priority and a responsibility shared by everyone; as such, the requirement to continuously improve quality and safety is inherent in all aspects of this position.

As part of a multidisciplinary health care team, the Oncology Nurse assesses, plans, provides and evaluates nursing care for assigned patients/clients in accordance with established policies, procedures and standards.

TYPICAL DUTIES AND RESPONSIBILITIES:

1. Assessment

2. Develops and implements Nursing Care Plan complementary to multidisciplinary plans of care for oncology patients/clients.

- Collaborates with other members of the health care team in the planning and provision of patient/client care.
- Coordinates patient/client care with other aspects of health care.
- Plans appropriate patient teaching.
- Anticipates discharge needs and consults others as appropriate.

4. Carries out nursing care using nursing skills and judgement according to hospital standards, including giving prescribed medications, therapeutic treatments and following through on physicians' orders.

- Documents the care given and observations made; reports significant changes in patient condition appropriately.
- Carries out teaching where appropriate as part of the care plan.
- Ensures a safe environment for patients and staff by observing universal precautions and infection control procedures, removing obvious hazards, reporting faulty equipment, and adhering to and enforcing rules regarding safety.

- Promotes patient independence and assists, where required, with activities of daily living.
- Acts as patient advocate.
- Acts as a resource person in the provision of nursing care for oncology patients/clients by collegially sharing, demonstrating and providing guidance.
- Participates in orientation of staff as required.
- Complies with new policies, procedures and standards by implementing changes in performance of duties as required.

- 6. Evaluates patient care and outcomes, modifying the Nursing Care Plan as appropriate.
 - Assists with the Quality Assurance Program by conducting audits, completing appropriate reports, providing feedback, identifying and following up on risk factors.
 - Makes recommendations for improvements to the unit and its provision of patient care to the Clinical Coordinator.
 - Participates in the development of unit and department statement of mission, philosophy, policies, objectives and standards.
