JOB SUMMARY:

In accordance with the Vision, Purpose, and Values, and strategic direction of Island Health (Vancouver Island Health Authority), patient and staff safety is a priority and a responsibility shared by everyone; as such, the requirement to continuously improve quality and safety is inherent in all aspects of this position.

Reports to the Manager, Renal Services. Provides nursing care to patients with chronic and acute kidney disease. Works both independently and interdependently as a member of the multidisciplinary team with other care providers. Establishes therapeutic relationships with patients and their families through assessment of bio-psycho-social and learning needs and works collaboratively with patients/families to support and facilitate informed choice and self care.

TYPICAL DUTIES AND RESPONSIBILITIES:

1. Provides individualized nursing care to patients with kidney disease by performing functions such as: educating about modality choices (e.g. peritoneal dialysis, hemodialysis, independent home therapies and transplant options and conservative care); care planning; assessing patient health status; identifying patient/family priorities and goals; planning, implementing and evaluating methods of care/nursing interventions; analyzing blood work and assessing fluid balance; conducting nursing interventions observing, monitoring; evaluating client progress, symptoms; recognizing and responding to anticipated and unanticipated client symptoms and responses to care and treatment, including urgent/emergent situations..
2. Collaborates with patients/families and team members, identifies care issues, re-evaluates priorities and revises care plans to assure coordination and integration of care. Acts as client advocate to promote and protect the patient's right to autonomy, respect, privacy, dignity, and access to information.
3. Establishes therapeutic relationships with patients/families by providing emotional support and performing assessment of patient/family learning needs, readiness and ability to learn. Provides information and explanations in-order to teach and involve patients/families in care activities. Utilizes health promotion and self-care philosophy to support optimal health and informed decision-making as it relates to maintenance and progression of kidney disease to end stage renal failure.
4. Through observations and activities documents/maintains complete and accurate records in accordance with established policies and procedures.
5. Participates in unit/team activities (e.g. chart review, data collection, task group/committees) to ensure quality assurance and quality improvement of care delivery and program operations. Identifies and reports unusual occurrence and critical incidents.
6. Guides clinical experience/participates in orientation of assigned new nursing staff.

7. Performs other related duties as required.

Registration with BC College of Nurses and Midwives as a practicing RN registrant.

Current Basic Cardiac Life Support (BCLS) certification required.
