JOB SUMMARY:

In accordance with the Vision, Purpose, and Values, and strategic direction of the Vancouver Island Health Authority (Island Health) patient and staff safety is a priority and a responsibility shared by everyone; as such, the requirement to continuously improve quality and safety is inherent in all aspects of this position.

Reporting to the Leader or designate, the Radiological Technologist works in a computerized environment, producing diagnostic radiographs as assigned and carrying out diagnostic procedures either independently or in collaboration with a radiologist or other physician; applies radiation safety principles and practices to protect patients, staff, and the general public; and completes required documentation and administrative tasks.

TYPICAL DUTIES AND RESPONSIBILITIES:

1. Verifies all patient information is accurate and correct by reconciling requisition information verbally with patient and checking relevant patient history.
2. Organizes and performs assigned radiographic examinations in accordance with established departmental policies and procedures. Performs Electrocardiogram (ECG) exams as trained and required.
3. Provides patients with an accurate description of radiographic examinations and associated risks, answering related patient questions.
4. Prepares and positions patients for radiographic examinations and procedures.
5. Prepares diagnostic agents and sterile trays as required.
6. Performs basic follow-up care post-examination, such as assisting the patient to transfer, dress, or to the washroom, and notifies the appropriate health care provider of any change in patient status. Collaborates with other staff to support efficient and timely management of patient care. Transports patients to other units within the hospital as required.
7. Documents and records examinations and procedures performed in accordance with established procedures.
 - Operates a variety of computer applications, such as Picture Archiving and Communications System (PACS) and Hospital Information/Radiology Information Systems (HIS/RIS), as well as a variety of digital and analog radiographic imaging equipment and accessory equipment, adhering to established procedures.

- Verifies and checks the quality and integrity of radiographic images within the electronic patient image file.
- Maintains policy and procedure manuals pertaining to the Medical Imaging Program, recommends changes, and updates as directed. Participates in Continuous Quality Improvement by conducting audits, completing appropriate reports, monitoring clinical indicators and satisfaction surveys, providing feedback, following up on risk factors, and making recommendations for improvements.
- Observes safety regulations, standards and procedures, such as use of equipment, infection control, and radiation protection. Reports accidents, injuries and near misses. Participates in Quality Assurance, Occupational Health and Safety, Fire Safety, and Infection Control Programs as required.
- Reviews quality control results, conducts initial troubleshooting to diagnose problems, and reports equipment and procedural problems/concerns to designated staff.
- Provides reception, patient booking and general clerical duties as required. Records and reports radiographic supply requirements for ordering in accordance with established procedures. Cleans and tidies work area according to departmental cleaning and safety procedures. Receives and stocks supplies and identifies depleted stock.
- Performs assigned administrative tasks, such as scheduling and timekeeping, as required.
- Demonstrates procedures and participates in orientation as required.
- Keeps abreast of technological developments by reading related literature, and attends in-services and workshops as required.
- Performs other related duties as required.

Canadian Association of Medical Radiation Technologists (CAMRT) certification as a Medical Radiation Technologist. Graduation from an approved radiology technology program. Eligible for membership in the CAMRT.
