#### JOB SUMMARY:

In accordance with the Vision, Purpose, and Values, and strategic direction of Island Health (Vancouver Island Health Authority), patient and staff safety is a priority and a responsibility shared by everyone; as such, the requirement to continuously improve quality and safety is inherent in all aspects of this position.

Under the direction of the Manager, Clinical Coordinator or designate and as a member of a multidisciplinary team, performs assessments, plans and provides personal care, and performs nursing procedures. Performs a variety of orthopaedic technician functions such as applying and removing casts and splints and setting up, monitoring, and adjusting traction equipment as directed by the physician. The Orthopaedic LPN operates in accordance with the competency guidelines and full scope of practice within the Standards of Practice as outlined by the BC College of Nurses and Midwives, and according to agency operating policies and standards and unit specific protocols.

#### TYPICAL DUTIES AND RESPONSIBILITIES:

- 1. Performs orthopaedic technician duties such as cleaning wounds and applying sterile and non-sterile dressings; applying, maintaining and removing casts and splints; setting up, monitoring and adjusting traction equipment as directed by the physician; and preparing patients and trays for minor surgical and medical procedures.
- 2. Assesses patient/resident/family's actual and potential strengths and limitations including physiological, psychological, socio-cultural, and spiritual needs. Where appropriate, encourages patient/resident participation in activities of daily living.
- 3. Contributes to the development and ongoing changes to the individualized plan of care, including attending and providing input into multidisciplinary care planning meetings and family conferences.
- 4. Performs nursing care and procedures and evaluates outcomes. Administers medications to assigned patients/residents according to unit specific protocols.
- 5. Participates in admissions, discharges, and transfers of patients/residents according to agency operating policies and procedures.
- 6. Documents and updates all relevant information about care and procedures to achieve patient/resident safety and
- 7. Assists in the orientation and continuing education of new staff, students, and other members of the Health Care Team.

- 8. Participates in continuous quality improvement and program evaluation activities, education sessions, team conferences, meetings and committees.
- 9. Performs other related duties as required.
