#### JOB SUMMARY:

In accordance with the Vision, Purpose, and Values, and strategic direction of the Vancouver Island Health Authority (Island Health) patient and staff safety is a priority and a responsibility shared by everyone; as such, the requirement to continuously improve quality and safety is inherent in all aspects of this position.

Working as a member of a multidisciplinary health care team in the Ambulatory Care setting and Specialty clinics or units, such as Endoscopy, Urodynamics, Minor Surgical Plastics and Cataract Sedation Nurse (as applicable to setting/site). The RN practices in accordance with the professional and practice standards and code of ethics as outlined by the BC College of Nurses and Midwives (BCCNM) and applies best practices in accordance with established organizational policies, procedures, guidelines, and other controls on practice to provide competent, safe and ethical care for people and their families in a variety of ambulatory care settings. Reports to the Nurse Manager, Department Head, or designate and acts in accordance with the unit/program philosophy, competency guidelines, policies, Canadian Nurses Association (CNA) Code of Ethics for Nursing and the BCCNM Standards for Nursing Practice in British Columbia

### TYPICAL DUTIES AND RESPONSIBILITIES:

- 1. Develops and implements a Nursing Care Plan complementary to multi-disciplinary plans of care, evaluating care and outcomes and modifying the Care Plan as appropriate by:
  - Assessing the health status of the client and promoting independence and decision-making by clients by including the client in care planning, priority setting, and care activities;
  - Identifying and prioritizing appropriate nursing actions such as preventative, therapeutic and rehabilitative aspects of care;
  - Collects data using a systematic nursing assessment of client needs using skills of observation, communication, and physical assessment;
  - Processes and implements physician orders, identifying and seeking clarification as necessary. Exercises judgment in assuming or performing delegated tasks or functions;
  - Protects confidential client information in accordance with Island Health privacy policies and procedures and FIPPA legislation

- Developing, evaluating, modifying and implementing written nursing care based on assessed needs and prescribed medical regime;
- Evaluating in an ongoing manner, the extent to which the client's health care needs are being met including assessing subjective and objective symptoms and self-care abilities, by noting critical lab values or significant changes in client condition and reporting same to the physician;
- Providing health teaching to the client and family/caregivers; Initiating discharge planning in conjunction with the client, family/caregivers, health care team members and community resources;
- Acting as client advocate to protect and promote client autonomy, respect, privacy, dignity and access to information;
   and
- Promoting good public relations and community awareness by effectively communicating with clients, families and visitors.
- 2. Functions as a member of the nursing team by:
  - Works within a team-based model of care. Collaborates with the Physicians, the client, the family/support
    persons/caregivers, other health care professionals, to synthesize information collected to develop a comprehensive
    share client care plan and to coordinate the integration of care and services.;
  - Participating in continuous quality improvement by conducting audits, completing appropriate reports, providing
    feedback, carries out assigned duties in support of the Island Health's quality improvement program and following up
    on risk factors and making recommendations for improvement to applicable policies, objectives and standards.
  - Acts as a preceptor or mentor to guide the clinical experience of assigned new nursing staff and students; provides input to the designated family physician(s) and/or Island Health Manger as requested on individuals' progress in achieving established standards of care.
  - Models Island Health values through methods such as demonstrating empathy, trust, and respect in all interpersonal relationships, and recognizes personal impact on team dynamics.
  - Ensuring a safe environment for clients and staff by observing universal precautions and infection control procedures, removing obvious hazards, reporting faulty equipment, and adhering to and enforcing rules regarding safety;
  - Identifies staff and material resources required to maintain a safe, comfortable and therapeutic environment for clients, visitors, and staff. Uses resources in a cost-effective way; and
  - Participating in the development of team, department and/or program statement of mission, philosophy, policies, objectives and standards.
  - Initiates, maintains and concludes a professional relationship with clients and colleagues using channels to communicate and resolve conflict.
- 3. Fulfils the responsibilities of and performs basic and specialised nursing skills as an experienced self-directed endoscopy/surgical/ambulatory care nurse to one or more clients in accordance with hospital policies, procedures and standards, including delegated medical functions, giving prescribed medications, therapeutic treatments and following through on physician's orders.
- 4. Documents care given and observations made according to BCCNM and Island Health documentation standards.
- 5. Maintains professional practice growth, knowledge and expertise to reflect current standards of practice by reviewing relevant literature, attending educational workshops and in-services, consulting and networking with other health care professionals. Adheres to Island Health policies, procedures, and guidelines to maintain a safe environment for clients and caregivers.
- 6. Performs other related duties as assigned.
