#### JOB SUMMARY:

In accordance with the Vision, Purpose, and Values, and strategic direction of the Vancouver Island Health Authority, patient safety is a priority and a responsibility shared by everyone at VIHA; as such, the requirement to continuously improve quality and safety is inherent in all aspects of this position.

Reporting to the Laboratory Unit Supervisor, responsible for the operation of the night shift by supervising night shift staff, carrying out related administrative duties, and performing laboratory procedures such as collecting, preparing, processing and testing laboratory specimens that are used by physicians in the diagnosis and treatment of patients.

### **TYPICAL DUTIES AND RESPONSIBILITIES:**

- 1. Supervises designated night shift staff by performing duties such as coordinating work assignments, evaluating, orienting, coaching and scheduling assigned staff. Participates in the selection and discipline of section staff.
- 2. Evaluates quality control information and takes corrective action as required. Forwards information to appropriate staff and Manager.
- 3. Performs analytical laboratory procedures such as chemical, microscopic, physiological, and bacterial tests in order to obtain data for use by physicians in the diagnosis and treatment of disease.
- 4. Collects, prepares and processes laboratory specimens for analysis.
- 5. Enters, retrieves, records and stores written or computer-based information and statistics related to specimen procurement, analysis and transport.
- 6. Performs routine instrument maintenance, cleaning and calibration.
- 7. Cleans and tidies work area.
- 8. Performs other related duties as assigned.

Successful completion of a recognized diploma program in Medical Laboratory Technology. Eligible for certification with the Canadian Society for Medical Laboratory Science (CSMLS). Two years recent related experience in an appropriate laboratory discipline.
